#### TCIHRC Reinforces Oversight Authority in Impromptu **Detention Center Review**

In October 2024, TCIHRC conducted an unannounced review of the detention center to assess conditions and ensure compliance with human rights standards. During the visit, the Commission engaged with officers to clarify its mandate, emphasizing its authority to conduct unscheduled inspections and access places of detention without restriction. This initiative underscores TCIHRC's unwavering commitment to safeguarding the rights and dignity of all detainees.

#### "Voices TCIHRC Hosts for Rights" **Community Dialogue on Human Rights Day**

On December 10, 2024, TCIHRC celebrated International Human Rights Day by hosting "Voices for Rights: A Community Dialogue" at Beaches Resort. The event brought together stakeholders, policy experts, educators, and community members to discuss key human rights challenges in education and housing.

Panel discussions addressed overcrowded schools and limited educational resources, emphasizing the need for collaboration to ensure quality education for all. Housing affordability and access were also highlighted, with calls for stronger policies to guarantee safe, affordable housing as a fundamental right.
